VOLUNTEER RULES & REGULATIONS

We would like to thank you for your interest and participation in Nebraska Pride 2008. In accordance with our new guidelines and policies the Executive Board of Rainbow Celebrations has enacted the following rules and regulations regarding volunteers.

1. It is understood that you are volunteering for a community event and you are not entitled to any form of compensation.
2. You have agreed to volunteer for a specific period of time and we ask that you fulfill that time period, as with an event this size staffing is critical to a successful event.
3. Volunteers agree not to “freeload” or otherwise use volunteering as a means to simply gain entry into Nebraska Pride 2008. Volunteers found freeloading will be asked to surrender any and all Nebraska Pride 2008 identification.
4. Volunteers serving or handling money or alcoholic beverages must be at least twenty-one (21) years of age and must have in their possession while acting in your position a valid form of identification.
5. Volunteers **must** not show up to volunteer under the influence of alcohol or drugs.
6. Volunteers may **not** consume any alcoholic beverages while performing your function for Nebraska Pride. Volunteers found consuming alcoholic beverages while performing their function may be asked to surrender any and all issued pride identification.
7. Volunteers will be badged or otherwise identified as to areas of access. Volunteers are asked to observe your level of access and not to attempt to gain access in areas of the festival you’re not allowed.
8. Volunteer understands once you fulfill your volunteering, you are **not** entitled to free admission to Nebraska Pride 2008. Volunteers are asked to remove any and all Nebraska Pride 2008 identification once you complete your volunteering.
9. Volunteer understands that safety and security of all attendees of Nebraska Pride 2008 is our utmost concern, therefore volunteers are asked to assist or otherwise report to your Pride contact person or on-site security, safety patrol or law enforcement any suspicious activity, dangerous situations or any other out of the ordinary activities.
10. Volunteer understands since you are volunteering your time at a community event, you are representing Rainbow Celebrations and Nebraska Pride. Volunteers are asked **not** to enter into or otherwise engage in controversial conversations or activities (i.e. protesters or others), volunteers are asked to simply walk away from those types of encounters. Volunteers found to be instigating or engaging in this type of activity may be asked to surrender any and all Nebraska Pride identification and escorted off the festival grounds.
